## LETTER OF APPOINTMENT

Dear Mr Karthik Veeramani

I am writing to confirm our decision to appoint you on the Board of Directors of Lotus Eye Hospital and Institute Limited with effect from 21.12.2022 This letter of appointment sets out the terms and conditions covering your appointment which are as follows:

### 1. Appointment

1.1 You have been appointed as a Non-Executive Independent Director on the Board of Directors (Board) of Lotus Eye Hospital and Institute Limited (LEHIL) with effect from 21.12.2022 Your appointment by the Board is in the category of Additional Director. Accordingly unless the shareholders appoint you as a Director, your term as Additional Director will be only up to the next Annual General Meeting of the Company (to be conducted in the year 2023).

1.2 Your term of appointment shall be for a period of 5 years up to 21.12.2027 and is subject to the approval of shareholders through general meeting/postal ballot. The Board will conduct a Postal Ballot sooner to seek your appointment by shareholders of the Company.

1.3 The Company has adopted the provisions with respect to appointment and tenure of Independent Directors which is consistent with the Companies Act, 2013 and the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015. Accordingly, the Independent Directors will serve for not more than two terms of five years each on the Board of the Company. The Company is at liberty to disengage Independent Director earlier subject to compliance of relevant provisions of Companies Act, 2013.

The Board of Directors (the Board) may, if it deems fit, invite you for being appointed on one or more existing Board Committees or any such Committee that is set up in the future. Your appointment on such Committee(s) will be subject to the applicable regulations.

## 7. Status of Appointment

7.1 You will not be an employee of the Company and this letter shall not constitute a contract of employment. You will be paid such remuneration by way of sitting fees for meetings of the Board and its Committees as may be decided by the Board and approved by the Shareholders from time to time. Further, you will also be paid remuneration by way of commission as may be approved by the Board and the Shareholders from time to time.

7.2 The sitting fees presently paid to the Non-Executive Independent Director is Rs. 50,000/- per meeting of the Board subject to applicable TDS. No separate amount shall be paid for committee meetings even if you are inducted into any of the statutory committees

## 8. Reimbursement of Expenses

In addition to the remuneration described in paragraph 7 the Company will, for the period of your appointment, reimburse you for travel, hotel and other incidental expenses incurred by you in the performance of your role and duties.

## 9. Conflict of Interest

9.1 It is accepted and acknowledged that you may have business interests other than those of the Company. As a condition to your appointment commencing, you are required to declare any such directorships, appointments and interests to the Board in writing in the prescribed form at the time of your appointment.

9.2 In the event that your circumstances seem likely to change and might give rise to a conflict of interest or, when applicable, circumstances that might lead the Board to revise its judgement that you are independent, this should be disclosed to both the Chairman and the Secretary at the earliest.

The Company will reimburse the full cost of expenditure incurred in accordance with the Company's policy.

The Company must include in its Annual Accounts a note of any material interest that a Director may have in any transaction or arrangement that the Company has entered into. Such interest should be disclosed no later than when the transaction or arrangement comes up at a Board meeting so that the minutes may record your interest appropriately and our records are updated. A general notice that you are interested in any contracts with a particular person, firm or company is acceptable.


### 13. Termination
